


Aerial View... Chattanooga, Tennessee



How can we go wrong with a theme like this? Isn't this really what being a Barbershopper is all about? As we go through the next 12 months, I challenge all of us to keep these 5 items in the forefront of whatever we do as Barbershoppers and I can assure you that you, your chapter, the Dixie District and the Society will have a wonderful and prosperous 2006!

District Vice President for Financial Development: I am very pleased to announce the appointment of Thom Hine as our District Vice President for Financial Development. Thom already has a wealth of knowledge regarding Harmony Foundation and will make an excellent VP in an area the DIXIE has not been able to fill for a couple of years. We all look forward to his contributions and wisdom as we move forward. Congratulations, Thom!

Dixie District Webmaster: Patrick Thomas asked to be replaced after several years as our Webmaster. We all owe Patrick a huge thanks for all the work he has done in designing and maintaining our web site over the years and we will miss his contributions. So when you see him, say "Thanks, Patrick!"

We interviewed several very capable and qualified Dixie members over the last few weeks of 2005 who were interested in taking on the Webmaster duties. I can honestly say that it was a very difficult decision with several phone calls between Don Lang and me in discussing the merits of each candidate. In the end, our decision was to offer the position to Bryan Chapman from the Memphis Chapter and he has accepted our offer to become the Dixie District Web Master. Bryan is a professional web designer in his work and we look forward to seeing the fruits of his efforts in this critical Dixie District position.

Why did we move our spring convention to Chattanooga?

In early November, we learned through a press release forwarded to us by Charlotte members that the Adam Mark Hotel (which was to be our HQ hotel for the spring convention) was being bought by a group of investors and that it was scheduled to close on Dec. 23rd. Quite frankly, we were between a rock and a hard place and had to get the best deal we could in a very compressed time frame. The Events team sprang into action and looked at alternative dates and possible sites in Charlotte, Knoxville, Dalton GA, the Atlanta metropolitan area, Greenville-Spartanburg, and Chattanooga. We also got conflicting reports from the Charlotte Convention Bureau about the fate of the Adams Mark, first saying they were closing, then they were staying open and remodeling. In the end, the Adams Mark never responded with a 'yes they were staying open and we'd like you to come' so we took the Chattanooga bid as the best offer.

Several years ago when DIXIE had divisions, we were losing money on our Division conventions. The BOD at that time decided that the best was to ensure profitable conventions was to eliminate the divisions contests and have only 2 conventions a year. Further, they also adopted a policy of having those conventions in the central core area of our chapters and member population. The other major factor adopted at that time was to negotiate long term contracts to get better cost considerations for the conventions.




FUN That we structure our meetings so that we all have fun, for if we don't have fun our members will certainly seek other outlets for their energy!

Charitable Involvement is Key!

Let me tell you a short story. This is the story of a Chapter Christmas Show that really made a difference. It helped a lot of people in the audience to feel the Christmas Spirit. It helped the Chapter secure operating funds for the next six months. And it brought the miracle of Christmas to a whole group of people who have no idea what Barbershop music

is or who we are.

For years, the Central Alabama Chapter has mounted a Christmas Show at the historic and very ornate Alabama Theater in Downtown Birmingham. Many Chapter patrons remember being part of the Mickey Mouse Club meetings at the Alabama, along with Saturday matinees complete with popcorn, Good 'N Plenty's and Cokes. Until 1996, the Alabama was still hosting its traditional Christmas at the Alabama show, featuring dancers, singers and performers of all ages.

So, when the Alabama Theater decided to retire its own Christmas show, the Central Alabama Chapter and its chorus, Voices of the South, took over. It seemed the most natural place in the world for a Chapter Christmas Show. The well-known and much-loved Cecil Whitmire, manager of the Alabama and its erstwhile organist, even consented to bring the Mighty Wurlitzer into service, playing a medley of sing-along Christmas favorites during Intermission.

Voices of Christmas at the Alabama was always a moderate success, selling a few hundred tickets and helping the Chapter through the lean spring months before the summer show. And so it was until 2005.

After the disaster of Hurricane Katrina, hundreds of Gulf Coast families were left living for months in temporary FEMA housing trailers in and around Central Alabama. Many were billeted at nearby Oak Mountain State Park.

Central Alabama's Board of Directors decided to donate a portion of the proceeds from the 2005 Christmas show to a United Way agency called Holiday Hope, which worked with Toys for Tots to get Christmas gifts to the children of these displaced families.

The charitable aspect of the performance got the attention of the local Clear Channel Radio Group, who partnered with the Chapter to publicize the show, giving away show tickets as prizes on two of its stations for two weeks leading up to the show. Chapter quartets performed on the air at the invitation of the stations' morning show hosts.

In addition, the Chapter secured the cooperation of a high-quality local restaurant and a local limousine company. A Grand Prize Package was assembled, including lunch for four before the show and limo transportation to and from lunch and the show. The restaurant and the limo company both donated their services for free. After all, it was for a good cause.

Chapter members sold tickets with renewed zeal, hoping to make enough money to provide a good-sized gift to the needy. People who may not have bought tickets in past years did so, just to help the cause. Show guests, the Harmony Hills Chorus of Sweet Adelines, International, sold tickets to help out too.

In the end, Voices of Christmas at the Alabama 2005 was the Chapter's most successful Christmas show to date, with enough proceeds to cover all the overhead, make a \$1000 donation to Holiday Hope, and get the financially-struggling Chapter back on its feet...all without spending a dime on advertising. Yes, posters were designed, printed and distributed. Yes, a mailer was used. Yes, email was used to a greater extent than ever before. All these efforts contributed to the success of the show. Some money was spent, but only a fraction of the expenditures of past years.



Membership Retention

“IT DOESN'T DO MUCH GOOD TO PUT LIPSTICK ON A PIG!” So, what does that have to do with retention, you ask? It suggests it takes much more than superficial things - like a speech or two, “dressing the duck in a swan costume”, “painting over the wood rot with two thick coats” or (add your favorite trite saying here ____), and calling it a job well done!

Retention is a serious issue that calls for a good plan of attack!

We've got to remember a Barbershop Chapter, like any service, or product in the marketplace, will succeed only to the extent it meets a need. It isn't complicated - if your dog won't eat the dogfood, you will stop buying it! If any member's barbershop experience is not meaningful, if it is not rewarding (fulfilling a need), that member will likely find reasons to leave the organization. This is a chapter-by-chapter issue, because virtually everything in barbershopping revolves around our experiences at the local chapter.

Retention warning signs (- like poor attendance, members coming late every week, some becoming inactive, someone didn't renew, or your quartet men aren't active anymore) are only the SYMPTOMS. You usually cannot solve a symptom - you must dig beneath to find and then fix the underlying problems. And many issues can be fixed!

Ours is a wonderful hobby and it offers lots of ways to meet a members' needs: A chance to harmonize the old songs with three other guys, a chance to have fun, a chance to make long-lasting friendships, an opportunity to perform and “show off” a little, a chance to do good things in the community and give back a little, a chance to produce and perform on an annual show, to be a bulletin editor, develop a website, to create scenery, write the script, be a section leader, a chance to grow tremendously as a singer and performer, to sing competitively in a quartet or chorus, to be a champion, to participate in convention activities, and more. We

ALL joined because we love to sing - and we all seek some form of fulfillment from this hobby. But - what fills one man's cup, can be another man's poison! We can and do have very different needs, levels of energy, different talents, and willingness to commit our time. Therefore, we need to find out what members want, and get them involved in doing it. There is no joy in sitting on the sidelines!

ATTACK RETENTION WITH A GOOD PLAN!

1. Schedule a CHAPTER PLANNING MEETING for a Saturday morning. (This can be at any time - but early in the year is perhaps best.) Have a paperboard, easel, markers, some masking tape - and promise everyone lots of FREE coffee and Krispie Kreme doughnuts! Either the Music VP or President should run the meeting.

2. The ONLY PURPOSE must be planning for 2006 - or it won't get done. Start precisely on time, and expect it to take at least a half day.

3. Get AS MANY MEMBERS AS POSSIBLE to attend (- and insist the Director and officers be there). This builds commitment, and gets more, and more people involved.

4. PREPARE TWO EASEL SHEETS IN ADVANCE.

SHEET #1: The top line says, “How did it go last year? Beneath that heading, make a list of topics to be discussed: Rehearsals, Chapter meetings, Parts Rehearsals, Recruitment, Number of Singouts and attendance, the Annual Show, Coaching, Social Activities, Singing Valentines, etc., etc.

SHEET #2: A sheet that says “Goals For 2006” at the top. The rest of the sheet is blank and will be filled in later.

5. DISCUSS SHEET #1 - “HOW DID IT GO?”

Discuss each topic on your list. Record the comments on a paperboard - so they know it was heard. Tape sheets up around the room. Have someone take good notes and type up minutes. Try to get everyone to speak up, to give their input.

6. LIST GOALS FOR '06

List what your members say they want to do! (like - number of

Quartet and Chorus Competitors ...

The 2006 Dixie District Spring Chorus Prelims and Quartet Contest will be held in Chattanooga, Tennessee on March 24-26. There will be three contest sessions held during the weekend. The College Quartet Prelims (one round) and the International Quartet Prelims (2 rounds) will begin at 7pm on Friday March 24th (this may be moved back to 6:30pm depending on the number of competitors). The Chorus Championship and qualification for the fall International Chorus Prelims will begin at 11am Saturday March 25th. The Quartet Prelim Finals will begin at 7:30pm on Saturday March 25th. All entries must be received by midnight Friday, March 10, 2006.

All entries, except College Quartet entries, must be filled in electronically via the internet. PLEASE have only ONE member of your quartet or chorus submit the entry form to me by following these steps:

All entries are electronic and are found on the Society Members Only webpage:

A... Go to the Barbershop Harmony Society home page and click on the red Members button in the upper right hand corner of the page.

B... Click on the red tab that says "Click to enter Members Only".

C... Enter your Member Number and Password and click on "Enter Members Only Area".

D... Go to the bottom of the page to the Contest & Judging Community and click on "Contest Entry (CJ-20)"

E... Click on the drop-down menu that asks "What group are you entering?" If your group is there, choose it and click "Next". If your group is not listed, go below the page and click either "Are you trying to enter your

QUARTET?" or "Are you trying to enter your CHORUS?" and follow the prompts.

F... Click on the "Choose a district", "Choose a competition", and "Next". As a quartet you will have THREE choices; Collegiate Competition, International Preliminary Competition, and/or For Score/Evaluation Only. You may enter more than one session if your quartet qualifies per C&J rules. As a chorus you will have three choices; District Preliminary Competition (a score of 900 points or more is required in order for your chorus to compete in the Fall Chorus International Prelims), the District Championship Competition, and/or For Score/Evaluation Only. Please note that choruses that are sitting out due to having won a championship in the last two years may opt to perform for Score/Evaluation Only if they so choose. I will need to hear from you so that these arrangements can be cleared with Events with the option of serving as a mic tester chorus may be considered as well.

G... ALL choruses need to enter "7" as the number of risers needed. Large choruses of greater than 70 members will sing toward the end of the competition on "9" risers. Estimates of chorus numbers are acceptable now. The computer program will automatically adjust for chorus plateaus in the Fall contest and exact numbers will be determined while the choruses are competing on stage. In the spring exact numbers will not be necessary since all choruses will be competing on the same number of risers and plateaus are not determined in this contest.

H... If your quartet or chorus does not wish to be EVALUATED by the judging panel, I need to know in advance of the contest so the judges can make changes in their evaluation schedules. If you do not let me know, I will ASSUME that you plan to be evaluated. Check the box on the entry screen as to your preference to be

Youth in Harmony

The College Quartet Contest is open to young men between the ages of ages 17 to 25, who will abide by the contest rules found at www.barbershop.org/college If you know of any potential college quartet contestants, please be sure to make them aware of the change in location of the Dixie contest preliminaries to Chattanooga on Friday, March 24.

Please remember that professionally designed brochures which include a mini-CD of several barbershop favorites are available for the asking that promote the college contest. These are the only means of publicizing the event this year, as the usual posters were determined to be ineffectual.

Again in 2006, the District will award a full scholarship (tuition and travel) to Harmony University, to a school music educator from the Dixie District. The dates of this week-long school are July 30 - August 6, and the location will be St. Joseph, Missouri. If you would like to nominate someone for this scholarship, send your letter of recommendation, along with a resume of the teacher, and a statement of assurance that that person will attend if selected. Deadline for this submission will be March 31. Submit to Youth in Harmony VP, 3385 Breton Court NE, Atlanta, GA 30319.

The Harmony Explosion Camp for high school boys will be held July 20 - 23 at Clemson University. The clinicians for the event will be Rick Spencer, from the Society, and Dr. Jerry Ulrich from Georgia Tech. As was the case last year, three standard and three barbershop songs will be learned and performed during the three day camp. We expect that around 100 campers and teachers will attend, and we will want to sponsor each of them, so that students pay only \$20 to attend and teachers are free.

If you or you chapter can be a sponsor, \$80 a person will be graciously accepted. The remaining costs will be covered by the District funds and by a Harmony Foundation grant. Please start now to find boys who will want to attend this camp.

Many chapters and quartets in the district are making good things happen with our youth. For 2005, I can report that in Dixie, at least 24 chapters had an active relationship with 166 schools (15 elementary or middle schools, 143 high schools and 8 colleges or universities). There were 6 festivals and 1 HX Camp. There were over 206 classroom visits, 16 performance opportunities for school groups, and 1 MENC Convention with a Barbershop Harmony Society presence. 2006 Spring Convention in Chattanooga

That's right... Chattanooga, not Charlotte.

Elsewhere in this issue, District President Dwain Chambers explains why we had to move the 2006 spring convention from Charlotte to Chattanooga, so I won't bore you with those details.

Instead, I'm going to tell you the really big news about the 2006 spring convention in Chattanooga. Chattanooga, remember Chattanooga. This is going to be a very interesting convention in a lot of ways. First of all, we will be in town (Chattanooga, keep saying Chattanooga) at the same time as the Region 23 convention of Sweet Adelines. There will be barbershoppers and singing everywhere! What is really going to be interesting is how our venues and their venues overlap. Region 23 has almost every room at the Marriott. Their contests will take place at the Memorial Auditorium. Our contests will take place in the Chattanooga Convention Center. The CCC, as you may recall, is connected to the Marriott. Well, we only have a few rooms at the Marriott, so the majority of our folks will be staying somewhere else. So, the ladies will be leaving the Marriott to go to their contests, and we'll be coming to the Marriott for our contests. Okay, not the Marriott, but right next door. Will You Help Yourself?

What is the Chapter Support Representative (CSR) Program and how do you help yourself and chapter benefit from this program?

Each chapter has an assigned CSR who is your direct link to the Dixie District and International Leadership. He is charged with the responsibility of communicating with the chapter leadership through your Chapter President on District and Society matters. This communication takes place in a number of ways to include e-mail and snail mail, telephone, and visits to the chapter. He keeps the chapter informed of district services, resources and opportunities. He develops a long-term proactive, positive, trusting relationship with the chapter leadership to help establish and reach chapter goals. It is not necessary for your CSR to have the answer to all your questions, but he has the ability and assets to find the answer or put you in contact with the proper person who will assist you. I believe, as do many others on the Dixie District Leadership Team, the ultimate success of the Dixie District Chapters depends on how well the CSR Program works.

A CSR is not a super barbershopper. More than likely he is closer to your average Joe barbershopper, who has a passion for our hobby, the ability to listen to chapter leadership, has a broad general knowledge of how we operate a chapter and can communicate ideas. One of his basic duties is passing good ideas that have worked in one chapter to other chapters that may successfully use them.

We currently have fifty-eight chapters and one licensee to support. There are fifteen CSR's of which only thirteen are currently active due to medical reasons. Some CSR's have been very active while some have not fulfilled their duties. Several have too many chapters to support (one CSR currently has eight) to properly do justice to this important program. The Southwestern District has no more than two chapters assigned to each CSR and in many cases CSR's have only one chapter. Another consideration is the distance between the supported chapter and assigned CSR. It does us no good to have an abundance of CSR's who live in Eastern South Carolina and none in Mississippi, Western Alabama, or Western Tennessee. You can see CSR's need to be geographically located close to their assigned chapters in order to minimize travel time.

Being a CSR is not an honorary position but one in which diligent work is expected and required. I can personally tell you the work is very satisfying and gratifying.

We need additional CSR's to make the program function to help all chapters in the District. **Will You Help Yourself?** I do not know all 1886 barbershoppers in the district or which of these would be a CSR candidate; therefore, I need your help in identifying good men to fill these positions. I challenge each Chapter President to nominate one of your chapter members to become a CSR. Please send me your nominee's name, address, phone number and e-mail address so I may contact them.

What a program we could have with thirty educated and dedicated CSR's helping our chapters grow and attain their chapter goals!

The men spend all day at the schools, working with several classes and different music teachers. Their objective is to make kids comfortable with singing a cappella, without relying on loud music. The men schedule assemblies for the whole school to attend while Bob and his crew sing and teach the love of music. Music teachers also get a nice supplement to what they do. Bob is a member of the 40 man General Assembly Chorus, Research Triangle Park NC Chapter.

Charlotte Chapter Installation of Officers

I attended the Chapter Meeting of the Charlotte Gold Standard Chorus Monday 12 December 2005. The meeting was a joint meal, award/installation service, and rehearsal. Heart of Carolina Chorus Charters ...

It all started with an email exchange on July 14, 2004, between Chris Slacke and Former Dixie District membership VP Bob Tilton, requesting information on starting a new chapter in the Durham, NC, area. That email kicked off a series of planning activities that resulted in the first meeting on October 19, 2004, at St. Luke's Episcopal Church in Durham. Since then it's been a marvelous year for the newly chartered Central Carolina Chapter, going from an idea to a fully functioning chapter in less than 12 months, with over 40 paid members singing with the new Heart of Carolina Chorus! (*Editor's note-Tilton will serve as District Executive Vice President in 2006.*)

One unique aspect of this new chapter is that it has also attracted strong and active participation from barbershoppers in the Danville, VA, area, about an hour north of Durham. Rehearsals are held in Durham and Danville to accommodate everyone's needs, creating a more regional feel to the group's make-up and influence.

After acquiring their license to operate in July, the chapter began the chartering process, and by August 1 had enough names to submit for formal chartering with the Society. The charter was approved on August 10, and the growth continued from that point. The Society's UCANSING2 program also began during the same time period, and

the chapter was able to participate in a big way, eventually winning the \$4000 second place prize for increasing membership by 150% during the nationwide campaign.

In August the Heart of Carolina Chorus had their first joint activity with the General Assembly chorus, (RTP Chapter, Raleigh, NC) singing the National Anthem together at a Durham Bulls baseball game. Then in October the first annual HOCC Golf-n-Glow event featured an all-day golf outing and pig pickin' afterglow at Caswell Pines golf club.

In early November the Heart of Carolina Chorus had its first official public appearance, under the direction of Chris Slacke, singing for the residents at the Emerald Pond retirement community in Durham.

On November 15, the chapter celebrated this first year of fun and the receipt of their Charter with a fabulous evening of singing, incredible food, laughter,

quartets, and a special "charter signing" ceremony. Chairman Larry "Special K" Kellogg pulled out all the stops and produced a memorable night for over 100 members, family, and Dixie District dignitaries, including Don Lang, Bob Tweed, and Charlie Rose.

Appearances by Snapshot and River Cities quartets rounded out the evening in a special way. The Central Carolina Chapter continues to grow under Chris Slacke's direction, and looks forward to entering competition for the first time in Chattanooga in March, and putting on a special "Cabaret style" show in May. The Chapter is planning for their first annual show in September.

The Heart of Carolina Chorus rehearses on Tuesday evenings from 7:00pm to 9:30pm at Blacknall Presbyterian Church, 1902 Perry Street, in Durham, NC, and every third Thursday at College Park Baptist Church in Danville, VA.



BIG News ~ BBS Recordings in MP3 Format

The Society has recently partnered with Naked Voice Records, LLC (NVR), in a collaboration that will have a profound effect on the availability of barbershop audio worldwide. NVR is a record label owned by barbershoppers (AIC members, in fact!) and dedicated exclusively to the digital distribution of a cappella music.

Within a matter of weeks, Phase I of the project will make available worldwide virtually every quartet and chorus contest performance recorded at International since 1999 (Anaheim) for digital download. This body of music will join the digital catalog of NVR already available through a variety of the most popular legal music download services such as iTunes, Napster, Rhapsody, MusicMatch, eMusic, LiquidAudio. These services offer legal digital downloads and/or streaming delivery of CD quality audio on a piecemeal basis. Both Apple and Windows based computers are supported both with and without the popular portable players such as the iPod, iRiver, Zen, GoGear, Sony and many more. Over the succeeding months, NVR hopes to digitize and add to the catalog available, all contest music dating back as far as the technology will allow. As you might imagine, old reel to reel tapes from the 40s are rather fragile so a by product of this effort will be the conservation and preservation of the Society's audio legacy. It is estimated that this initiative will ultimately result in an available barbershop catalog of tens of thousands of tracks!

No more will you have to listen to stories from other barbershoppers about the incredible-haunting-outrageous-humorous-poignant (insert your own adjective)

Write them specifically with dates, numbers and give people assignments.) This constitutes the plan and the Board needs to make sure it is getting done.

The ANNUAL CHAPTER PLANNING MEETING will help enormously to focus the Chapter on what members want/don't want and are willing to do; what they feel is important, what is a problem, etc. In the end you've established a clear direction for the year and because many members have been a part of this process, the resulting plans will be meeting their needs. As one great Vaudeville actor would say, "Just give 'em what they want and they'll always come back for more!"

evaluated or not. Choruses please note: Evaluation sessions will continue to be set up based on ORDER OF FINISH rather than ORDER OF APPEARANCE. This is important in that the judges will have an opportunity to share input with all levels of chorus performances and not be restricted to just the lower or upper scoring choruses. This is the same way that quartet evaluations have been done for years. Don't leave the contest area too soon before you know where your chorus places or you may miss your chorus evaluation.

I... Please include all information including any special requests such as "need to sing late due to travel distance" or "need to separate quartets or choruses due to members singing in more than one group", etc in the comments box. Quartets that desire to sing early will be taken on a first come/first served basis. The host chorus will have the choice of singing first or near the end of the competition. Very large choruses will normally sing last.

J... Any chorus that wishes to compete for Score & Evaluation Only must let me know in advance as well. I will accept those on a first come/first served basis only dependent upon the number of choruses that register.

K... When finished, click on "Submit". A copy will be
