
Dixie District Spring Convention in "Rocket City"

The Spring 2015 Dixie District Convention and Contest will be held in Huntsville, AL on March 13-15. The convention venue will be the East Hall of the Von Braun Center in downtown Huntsville. The headquarters hotel is the Embassy Suites next to the Von Braun Center.

Registration for the convention is now taking place online at **www.dixiedistrict.org.** The registration price is \$51. However, an early bird registration rate of \$41 is available if made before March 1. A mail-in form is also available on page 3 of this issue.



Spring Contest Information

Gentlemen Songsters!

The time is upon us once again to gather at the Embassy Suites Huntsville, 800 Monroe St. SW, Huntsville, AL 35801 (256-539-7373) on March 13-15 for the 2015 International Quartet Prelims and Dixie Chorus Convention. This convention will be held under ONE ROOF, with the Von Braun Center serving as our contest site, and will be very convenient for all attendees. I am depending on each of you to be sure that this word gets out to every member/competitor/performer in your chapters. Check out the Society website in the eBiz section under Contest Entry to fill out your chorus or quartet CJ-20 contest entry form. We will have an International Quartet Prelim (2 rounds), a District Chorus Championship, and a Most Improved Chorus award based on chorus scores from last spring. We will also offer a Score for Evaluations Only session for those choruses/quartets who do not wish to compete but would like to receive your personal score sheet and a 60-minute coaching or 45-minute evaluation session. We just need YOU there to participate!

Also if there are those choruses who do not wish to participate in the contest but would opt for a **small chorus festival** in conjunction with the contest festivities, I need to hear from you **post haste!** We are striving to put together a cadre of **Dixie coaches/judges** apart from our regular judging panel to work with **2-3 choruses/quartets who are not choosing to compete or perform for Score/Evaluation Only** for at least **1 1/2 hours each** and possibly put together a **megachorus** of these festival groups to sing in the **Joe Barbershopper Chorus** on stage and, possibly, on the **Chorditorium stage** Saturday night. Again, **I need to hear from your chapters** if you have **ANY interest** in this festival so that we can begin planning for those needs

As promised, the Evaluations/Coaching sessions following each contest session will be YOUR CHOICE. You MUST let me know what YOU want in the way of coaching or evaluations on your entry form in order to be entered in the contest this fall. YOU MUST ENTER YOUR CHOICE OF EVALUATION OR COACHING in the Comment section of the CJ-20. ENTRY FORMS (CJ-20's) will not be complete until I have YOUR CHOICE of evaluation/coaching listed below. Please look at these and make your choice in advance of filling out your entry form. Then make sure you have indicated in the comment section of the CJ-20 what your desires are for evaluation or coaching. Here is the list along with the judging panel that will be on tap for our contest:

No Evaluation or Coaching
Evaluation Only-3 judges 15min each
Coaching-3 judges 20min each
Coaching-2 judges (SNG/PRS) 30min each
Coaching-2 judges (SNG/MUS) 30min each
Coaching-2 judges (MUS/PRS) 30min each
Your choice of judges (based on 1st come/ 1st served) for options 3-6 (indicate in comment section on CJ-20)
Other option if not listed above (Indicate in comment section on CJ-20)

Judges who are on the Official Panel: MUS- Steve Jamison & Raymond Schwarzkopf; PRS-Dwain Brobst & Barry Towner; SNG-Harry Haflett & Chad St. John

If you have any trouble filling out the CJ-20 for your chorus or quartet, PLEASE contact me ASAP and allow me to walk you through the process. I didn't cut and paste that lengthy process into this article because it is so bulky and I'm not sure most of you even read it. If you need it, I will be more than happy to send you a copy for you to work through it. Again, I am available to help you fill out your CJ-20's if needed.

The cut off for CJ-20 entries for this convention is midnight February 20th which NOW gives you three weeks to get your entries filled out. That is 3 weeks from the start of the convention weekend. Please let me hear from you SOON as to what your plans are for this convention. I would like to know what your intentions are as early as possible so that I may contact you to discuss the possibilities with you.

I will be sending out weekly reminders as to our progress. Dixie District Notes Passing of Two Hall of Fame Members

CHARLES PHILLIP MCCANN

Charles Phillip McCann, age 86 of Nashville, TN went home to be with the Lord on January 19, 2015.

Charles was born in Nashville, TN on November 7, 1928 to the late John & Hazel McCann and was raised on a farm in Brentwood.

He attended David Lipscomb High School and graduated with honors from Vanderbilt University's School of Engineering in 1950. He began his career with McCann Steel Company, a family business, and later started his own engineering firm, Charles McCann and Associates. He retired as a structural engineer and closed his firm December 31, 2014.

Charlie had a passion for a cappella four part harmony and was a member of the Barbershop Harmony Society for more than fifty years. He served the organization at the local and district levels before being elected International President of the Society in 1990. Among the many honors Charlie has received are the Chapter and District Barbershopper of the Year award and was inducted into the Dixie District Hall of Fame. Over the years he sang in several registered quartets, including three district senior champions.

He was preceded in death by his loving wife Jean Barrett McCann; daughter, Penelope Joyce (William) Waller; and sister, Dorothy McDonald.

Survivors include his soul mate; Betty Shelton; daughter, Kathy (Robert Lee) Smith; sister, Carol Burden; brother, John (Ruth) McCann; 6 grand children; 10 great grandchildren and a host of nieces & nephews. The family received friends on Saturday, January 24, 2015 at Harpeth Hills Funeral Home where a celebration of Charlie's life was conducted on Sunday January 25.

A Graveside service was held Monday, January 26, 2015 at Harpeth Hills Memory Gardens.

THOMAS JOE HINE

Thomas Joe Hine died at Tranquility at Kennesaw Mountain on December 28, 2014, ending his 3 ½ year battle with cancer. He was peaceful and surrounded by his family. A memorial service for Thom was held on Saturday, January 3, 2014 at Alpharetta First United Methodist Church in Alpharetta, GA.

Thom was born on August 19, 1935 in Martinsville, Indiana to June and Marion Hine. At age 14 his high school shop teacher wanted to form a barbershop quartet, and the rest, as they say, is history. He quickly developed an incredible love of vocal harmony and barbershop singing that led him to lifelong friends, his wife, Carla, of 52 years, and a family connected by love and music. Thom was a 64-year member of the Barbershop Harmony Society (BHS), and tirelessly shared his passion and his talent for singing and for leadership with barbershop singers across the US and around the world.

Thom graduated from Proviso Township High School (Maywood, IL), and received a Bachelor of Arts degree in Economics from Lake Forest University (Chicago, IL) in 1957, where he was a member of the Kappa Sigma fraternity. He served in the US Army and Illinois National Guard, achieving the rank of Specialist E-4. After college he worked at Goodyear Tire and Rubber Company, then was employed in various roles at Allstate Insurance Company for 33 years, retiring in 1993 to pursue his passion - barbershop harmony.

Throughout his life he lived in many places, including Indiana, the Chicago area (a few times), Arkansas, North Carolina, Ohio, Michigan, and finally metro Atlanta, as director and then Director Emeritus of the Big Chicken Chorus, and then as a member of he Atlanta Vocal Project. Thom loved coaching and teaching barbershop harmony, and directed several choruses throughout his life. He sang in many quartets, including the popular Midnight Oilers, The Four Henchman (11th place, International Barbershop Quartet Competition in 1982), The Atlanta Forum (Dixie District Quartet Champions with his son, Clay, in 1987), and The Old Kids on the Block (International Senior Quartet Champions in 1991).

Thom is survived by his loving wife, Carla Beyer Hine, his sisters Patricia Haskett (Carmel, IN) and Jean Morgan (Scottsdale, AZ), his sons, Clayton and Bradley Hine, their wives Becki and Georgia Hine, grandchildren Melody, Camden, and Kelso, and the thousands of people he made part of his extended family.

We'll miss you Thom...but the bass section in heaven just got a whole lot better!
